B. Approval of Minutes for January 2022

C. Update from President – Sattler

- Madison Park Discussion with Mayor
 - Lakewood city leadership was receptive to LUFC's concerns; though a police officer during practice isn't feasible
 - Security guard 7-days a week will continue
 - Parks ambassadors (like CLE yellow shirts) will start at the park in late march
 - They Mayor and police chief offered a day for LUFC families to meet with the Mayor and the police officer stationed nearby (minutes away) to help people feel comfortable
- Madison Park Next Steps
 - Leisa will draft a communication for families and get it to Matt tomorrow
- Directors of Coaching
 - Toth – still recruiting coaches, DOC requirements are being reviewed. Matt will talk more with Toth
 - Ryco – Matt is working on connecting Ryco

D. Registrar/Scheduler's Report – Pietromica

Registration and scheduling need to be separated into two jobs

Need board members to step into these roles

Note: Scheduling is a paid position

- Registration review/update – 206 currently
- Discussion of individual teams – coaching assignment, roster combinations and division assignments
 - Boys: Discussion around Boys 2009 and youngest group (2014 – 2016) related to roster assignment. Leisa will work with Toth to finalize decisions on team placements
 - Girls: appears to be in good shape
- Team declarations – reviewed the process. Tony needs someone to attend the meeting with him on March 20
- Registration will close – February 28, 2022
 - LUFC Board can add people after that date – strategic additions
 - Matt will communicate this with the Rec
- Practice schedule
 - Draft is available on the shared drive, next step is to talk to the coaches
 - Some teams will start practicing as early as mid-March

- Equipment – Tracy
 - Landon will inventory the equipment
 - Want to get starter kits with pinnies, cones, etc. Will need to get requisition into Rec asap

 - Reviewed rationale for drafting this – based on an email that went out last fall
 - Lisa will get Toth's feedback and if it looks ok, approval to distribute
 - Chelsea asked about the club's view on age group practice
 - Philosophically the board is strongly in favor – the girl's side always practices this way
 - Boys side, less so. It's part of team expectations so will be reviewed with DOC
